

Better Meds Medication Supply Request and Pharmacy Integration



The Medication Supply Request Module is part of Better Meds, version 3.7.0.



»Having the new integration functionality will allow our nursing staff to order medication electronically, reducing the time it takes for supply requests to be received into the pharmacy department as well as reducing errors that may be associated with paper ordering (such as ambiguous handwriting). The automated feedback to wards around the supply requests is expected to reduce duplicate ordering and telephone queries received by the pharmacy department, reducing interruptions to the dispensary and resulting in a faster supply process. Ultimately all of this will improve the speed we get medicines back to our patients for administration and discharge, the safety of our supply process and the service that our patients receive as a result of these improvements.«

THE CHALLENGE


The digitalisation of healthcare has great potential, but the lack of cooperation among healthcare IT providers in the market negatively affects the interoperability of different systems, sometimes even within the same healthcare institution.

In hospitals medications are predominantly ordered in an ePMA system (if installed), and then manually transcribed into the pharmacy system. This transcribing process can be accompanied by many errors, and is also very time-consuming. This problem is further compounded when a hospital has ePMA and Pharmacy systems both installed, but from different suppliers, and they are not integrated. However, if both systems have structured data and follow the same healthcare standards, or are integrated, ordering supplies can be done automatically with a single click, thus improving both safety and efficiency.

THE SOLUTION

A hospital using Better Meds and a pharmacy management system from a different provider, can now easily decide to integrate both systems by using INTEROPen CareConnect FHIR profiles to create the best possible experience and provide better and safer working conditions to clinical teams.

The data is now automatically transferred between both systems, which reduces transcribing errors, saves time, and facilitates better communication between healthcare professionals. All of these elements combined lead to increased patient safety.





BENEFITS AND COURSES OF ACTION

The main benefit for clinical teams is the ability to order medications from the in-hospital pharmacy with a single click. Nurses and pharmacists can now see when the medication is dispensed, or whether a supply request has been rejected.

Following is a list of actions that users can perform with an Better Meds supply request when it is integrated with the pharmacy system:




Nurses:

- \checkmark can order and cancel supply requests.
- \checkmark can mark the status of supply requests.



Pharmacists:

- \checkmark can manage supply requests (accepting, suspending, or rejecting them).
- ✓ can mark requests as "dispensed", "rejected", or "on hold".



THE BETTER MEDS SUPPLY REQUEST PROCESS

1 Submitting a supply request

This is a simple process. Nurses create supply requests from the drop-down menu. There, they can order more than one medication at once, and add comments to each request. Once medications are ordered, they can see all the details in the supply request card, and also cancel any already ordered medications.

2 Reviewing supply requests

Once supply requests are created, pharmacists have the option to review them. They can see a list of patients who have the supplies which have been requested. Pharmacists can then review the supply requests for each patient, and have the option to confirm, reject, or suspend each (or every) supply request. When suspending or rejecting a supply request, it is mandatory to provide a reason. Pharmacists can also check all inpatient prescriptions as well as a patient's allergies. They also have information on whether a clinical screening of medications for a given patient has already been done.

When supply requests have been confirmed, they are automatically sent to the pharmacy system. If a request has not been received by the pharmacy system, the user who is confirming the supply request receives a notification.

3 Status of the dispensing process / Information about the dispensing process

In case of integration with the pharmacy system, in Better Meds, the status of the supply request will be shown once it is in the dispensing process. The user will be able to see whether the order has been dispensed, rejected or put on hold. In hospitals without integration, a user with appropriate
